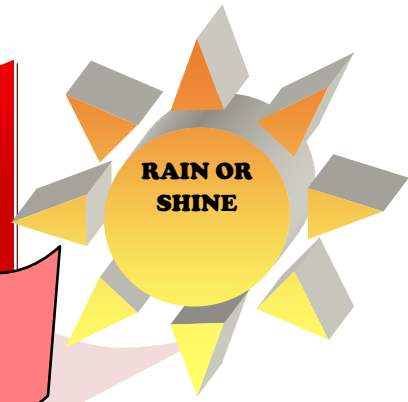


CLASS OF 2018 SENIOR UNITY DAY
